# Guarantee and Sale Agreement

1. To be sound and free of communicable disease for a period of 48 hours. Buyer agrees to have dog checked within 48 hours by his or her own DVM at his own expense.
2. Guarantee is void if dog is sold or transferred to another owner.
3. Under no circumstances will the purchase price of the dog be returned. Breeder may replace any dog should circumstances warrant replacement within 1 year, such as, if the puppy is found to have a serious life threatening genetic defect.
4. Replacement will be provided by this breeder if the dog fails to live up to guarantee outlined in this contract. Replacement time and selection is up to the breeder, but shall not be withheld unwarrantedly, or unreasonably. The dog to be replaced must be brought to the breeder, along with any medical records and findings from the buyers VET, for evaluation before replacement. If the dogs' health is in question, the buyer agrees to have the dog checked by the DVM of the buyers' choice, at the expense of the buyer. Both the buyer and the seller agree to abide by the diagnosis of the aforementioned DVM.
5. In any replacement circumstance, registration papers are to be signed over to the breeder, and the animal returned before replacement at buyers cost. Should the buyers DVM unavailable, the buyer agrees to use the DVM of the breeders' choice.
6. If at any time in the future it becomes necessary for the buyer to "place" the dog in a different home, the buyer agrees to contact the breeder and offer the dog, as right of first refusal. This offering to the breeder first, in no way obligates the breeder to purchase the animal.
7. If for any reason buyer is unable to keep the mentioned dog, Seller will help place the dog in a new home for the entire life of the dog. In no event, will the dog ever be turned over to a shelter, humane society, or dog rescue group.
8. **By signing this contract buyer agrees to provide a good, living home for the dog throughout said dog's life.** This dog will be kept indoors food, and water, and not be allowed to roam freely outside.
9. In cases where the dog or puppy is to be shipped via air all precautions will be taken by seller to ensure safe travel. In the event that death would occur during shipping puppy will be covered by insurance of the airline for the cost of said animal plus shipping fees. These costs will be refunded through this insurance.
